Revenue Determination Process 2019-2023

Expenditure Forecast Methodology 30 Jun 2016	ElectraNet advised the AER of its approach to forecasting capital and operating expenditure.		
Framework and Approach 31 Jul 2016	The AER published the final Framework and Approach for ElectraNet's Revenue Proposal. This framework and approach paper is the first step in the process for the AER to determine the revenue that ElectraNet can recover from customers over the five year period from 2019 to 2023.		
Preliminary Revenue Proposal 6 Sep 2016	ElectraNet released its Preliminary Revenue Proposal which focused on indicative capital and operating expenditure forecasts and provided an indicative revenue and price path outlook for the 2019-2023 regulatory period.		
Revenue Proposal 28 Mar 2017	ElectraNet's Revenue Proposal outlines the program of work (operating and capital expenditure forecasts) and forecast revenue required to maintain and operate a safe, reliable and efficient network. The Revenue proposal must meet the long term needs of electricity consumers.		
Issues Paper 25 May 2017	The AER identifies early key issues likely to be relevant to its assessment. This includes the 'first pass' assessment indicating their preliminary view on ElectraNet's Revenue Proposal.

Public Forum 7 June 2017	The AER and the Consumer Challenge Panel present to stakeholders the early issues and discuss how stakeholders can provide input into the process. ElectraNet is provided the opportunity to give a summary of the Revenue Proposal.		
Draft Determination Oct 2017 (TBC)	The AER uses a range of evidence to review and assess the Revenue Proposal, including historic trends of past costs, benchmarking against comparable businesses and expert advice. The Draft Determination includes the draft total capital, total operating forecasts and revenue the AER considers are efficient, taking into account stakeholder consultation.		
Pre Determination Conference	The AER and the Consumer Challenge Panel present to stakeholders to explain the Draft Decision.
